



INSTRUCTIONS FOR 2015 RIDER 'S LICENCE APPLICATIONS AND LICENCE FEES

The filled in application form with the medical confirmation needs to be send together with the appropriate licence fee to the SMF secretariat. The application form can be send by post or by e-mail.

When paying by a bank transfer, please indicate your name in the message for the recipient.

Riders over the age of 45 must attach with the medical confirmation also the ECG result.

The application form of riders under the age of 18 must be signed by both parents (or legal guardians). The signatures must be verified.

New riders of the youth motocross (classes 50cc, 65cc, 85cc) must also attach a verified photocopy of the birth certificate.

Before issuing a licence to a foreign rider, the SMF must obtain an approval (release) of the federation of the country of which the rider is a national or in which he/she is a permanent resident. The rider himself must apply for this release at his federation.

SMF LICENCE TYPES:

International licence type A – holders of this type of licence can participate at national SMF events and also at international events abroad (**not** World Championship/Cups or European Championship/Cups). The use of this type of licence abroad is only allowed with a start permission. The start permission can only be issued to riders with valid insurance covering medical treatment, transfer to a hospital and repatriation.

National licence type B - holders of this type of licence can participate at national SMF events.

For World Championship or Cups or European Championship or Cups the appropriate *FIM* or *FIM Europe licences* are needed.
