

SUPPLEMENTARY REGULATIONS



MACEC Trial Cup International Trial Championship of Slovak Republic and SMF Trial Cup 29.-30.8.2020, Zbora, Slovakia

ORGANIZER: Trial klub Kamikadze, Zbora 124, 020 51 Dohňany, Slovakia, IČO: 42375908

- **1. The competition** is organised according to the SMF National sporting code for Trial, valid for 2020 and these Supplementary Regulations.
- 2. The race can be attended by holders of FIM, FIME, SMF licences or one-event licence for the appropriate discipline. Foreign riders can participate with valid licence and a start permission of their National federation. Riders under 18 years of age can only receive a one-event licence in accordance with the article N 052.1 of the SMF National Sporting Code (warning back protector mandatory). The event is announced for groups A, B, C and Student over 8 years of age as International Slovak Championship. Categories Free, Hobby, Women and Classic as SMF Cup. Category Student under 8 years of age as National Slovak Championship.

3. Colour coded categories:

A: yellow B: green C: C: Student over 8 years of age: blue Women: according to the performance

Student under 8 years of age: free pass Classic: blue + letter "C" Hobby: blue Free: white

4. Venue: ZBORA a Mestecká skala GPS 49.1770153, 18.2839745

5. Date of the event: 29. - 30.8.2020

6. The track leads outside of the civil traffic. The length of one lap is 7 km:

Variant A: 15 section, 2 rounds Variant B: 10 sections, 3 rounds

Length of a lap for category Student is approximately 0,5km, has 8 sections and 3 rounds. Terrain: clay, water, roots, rocks, gorges, steep exits and descents, jumps, challenging crossings.

- **7. Riding time:** 360 minutes, of which max. 220 minutes for **Variant A** and max. 180 minutes for **Variant B**. The rider will be allowed to start the second round only after: at least 120 minutes have elapsed from the start of the rider to the competition **Variant A**; or at least 90 minutes have elapsed from the start of the rider to the competition **Variant B**.
- **8.** The event has the third-party liability insurance cover. Each rider will confirm with his signature on the Technical card, that he has an accident insurance cover, foreign riders also medical treatment, transfer to a hospital and repatriation insurance cover. The organiser doesn't undertake responsibility for any possible damage and losses occurring in relation to competitors and their equipment as well as directly or indirectly to third-parties and their property.
- **9.** In accordance with the valid SMF general rules, riders without driving license are not allowed to ride bikes outside the race course.
- 10. Entries: due to the present situation caused by the COVID-19 virus, it is necessary to make on-line registration for the event in advance via the SMF website: www.smf.sk/trial-online-prihlasenie/ by the 26.8.2020 at the latest. After this date, it will be only possible to enter via email trialkamikadze@zoznam.sk Riders who did not register in advace will have to pay at the administrative verification the entry fee for both days.





11. Administrative and technical control will be done in accordance with the regulation NO52,1 of the SMF National sporting code.

12. Starting fee:

A, B, C, Free, Classic 25 € / day Hobby 20 € / day

Women 10 € / day (if they want to score also in another category, the starting fee

mentioned above, applies)

Student over 8 years of age 10 € / day Student under 8 years of age 5 € / day

In case of a payment for both days together, there will be a discount of 5 €. This does not apply for category Women and Student, also this does not apply for riders who did not register in advance.

The Jury meetings will take place in the paddock.

15. Results announcement: The result announcement of all categories (apart from categories Junior and Kadet) will take place each race day 30 minutes after the arrival of last rider.

The result announcement of categories **Junior and Kadet** will be for both days together – **only for SMF licence holders**.

- **16. Prize money:** First 3 riders of the overall classification for both days together will receive financial reward. In case of a tie, a better result on Sunday will be decisive.
- **17. Environmental regulations:** Washing of motorcycles is forbidden, except for areas designated for this purpose. The use of any chemical substances is not allowed. It is forbidden to spill used oil and another





waste outside of marked containers. The use of environmental mat (made of absorbing material, minimum size 1,6 x 1m) is compulsory while parking, repairing, refuelling the motorcycle in the paddock or on track. Canisters with oil and petrol and their throats must be set out of the sunlight on an environmental mat. Participants and their accompanying persons have to respect the night-time quiet time set by the organizer and secure their motorbikes and other valuables against damage and theft. It is forbidden to destroy the flora and fauna in the whole event area. These directions are mandatory and are in conformity with the NR SR law number 543/2002 ZZ. Any violation of the environmental rules can be penalised individually by a fine of $40 \in$.

18. Refreshment: will be available at the venue in compliance with the valid hygiene measures in relation to COVID-19.

- **21. Protests:** Protests may be lodged only according to the SMF National sporting code for trial a written protest together with a deposit of 35 € must be given to the clerk of the course within 30 minutes after the result announcement. The deposit will be returned if the protest is justified. Protests in sections are inadmissible.
- **22. Epidemiological measures:** The organizer will require all participants to comply with the currently valid measures in connection with the COVID-19 disease, which will be incorporated into the operating rules of the event.
- **23. Paddock** will be divided into 4 sections according to the nationality of riders. Each section will be marked. Riders are obliged to comply with this rule.
- **23.** The organiser has the right to make changes to these Supplementary regulations.
