## 6. **STARTING NUMBERS**

From the second event onwards the rider will start class by class in their respective classes following the order determined by the provisional classification of the previous rounds. The organizer must provide the rider with the race numbers at administration. Rider must ensure they have the correct colored number plates for their class.

DAY1: The course for the first day shall consist of 3 laps of a 84 km course which will include 3 time-checks/lap.

There will be a total of 3 special tests, of these will be closed course tests and will be additional timed tests.

The location and length of each test shall be displayed at the official Noticeboard at the Metzler-Truck in the Paddock from **Thursday, 3<sup>rd</sup> August 2017**

**13. INSURANCE**

By endorsing the application form for entry, the FMN of the rider certifies that the rider is insured in accordance with the FIM Europe requirements.

The organizer has to cover third party insurance in accordance with Art. 110.1 of the FIM Europe Sporting Code. This insurance includes a guarantee of the minimum amount as stipulated by the FIM Europe Management Council. The Insurance comes in effect 2 days before the first practice and ends after the prize-giving ceremony of the meeting.

The organizer disclaims all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other incident.

**14. PROTEST AND APPEALS**

Any person or group of persons (rider, entrant, manufacturer, official, etc.), recognized by the FIM and concerned by a decision taken under the authority of the FIM Europe, may ask for redress for the consequences of that decision.

Protests must be lodged according to the Disciplinary and Arbitration Code of the FIM Europe and the Supplementary Regulations and be accompanied by a fee of 130,- € or the equivalent amount in local currency, returnable if the protest is justified.

In general, protests against eligibility of a rider, must be made before the start of the official practice.

Protest against results must be presented to the international Jury within 30 minutes after the provisional results have been published. An appeal against a decision of the International Jury can be made to the FIM Europe Disciplinary Commission.

Protest entailing a fuel control: See FIM Europe MX rulebooks.

15. **PRIZE GIVING CEREMONY**

Venue of the prize giving ceremony: **Starting Area**

Rider who qualify for prizes are invited to attend the prize giving ceremony. The invitation to attend at the prize giving ceremony and press conferences is compulsory.

16. **INTERPRETATION OF THE SUPPLEMENTARY REGULATIONS**

The interpretation of these regulations is the responsibility of the Jury. In case of a dispute, regarding to the interpretation or if there is any difference between the two official texts, the English text is decisive.

17. **MISCELLANEOUS**

Transponder: The maximum fee for transponders rent is 100,-€, the fee has to be returned after the transponder is received back.


