



Supplementary regulations

of the International Trial Championship of Slovak, SMF CUP in the category of student and free

- 1. The competition** is organised according to the SMF National sporting code for Trial, valid for 2014 and those Supplementary Regulations. The race can be attended by holders of FIM and FIME licences, holders of SMF-licences type A or B for trial, holders of licence for another disciplines within SMF, or one-event licence (valid only for certain race) for competitors without licences mentioned above. Foreign riders can participate with valid licence and a start permission of their National federation. The event is announced for groups A, B, C – International Slovak and Czech Championship and for classes student and free – SMF Cup.
- 2. Colour coded categories:** A - yellow, B - green, C - red, Free - white, Student - blue
- 3. Venue: Nitra – KALVÁRIA**
(GPS: 48.289189721, 18.088377714); (48° 17' 21.082995" N, 18° 5' 18.159771" E)
- 4. Date of the event:** 9 – 10 May 2015
- 5. The track** leads outside of the civil traffic. The length of one lap is 1,5 km, where each lap has 10 sections, and 3 rounds for all categories. Riding time is 360 minutes.
- 6. The event** has the third party liability insurance. Each rider will confirm by signature on the Technical card, that he has an accident insurance cover, foreign riders also medical treatment, transfer to a hospital and repatriation insurance cover. The organiser doesn't undertake responsibility for any possible damage and losses occurring in relation to competitors and their equipment as well as directly or indirectly to third-parties and their property.
- 7.** According to the valid general rules of SMF, riders without driving license are not allowed to ride bikes outside the race course.
- 8.** Administrative and technical control will be done according to the regulation NO52,1 of the SMF National sporting code.

13. Environment: Washing of motorcycles is forbidden, except for areas designated for this purpose. The use of chemical any chemical detergents is not allowed. It is forbidden to spill used oil and another waste outside of marked containers. The use of environmental mat (made of absorbing material, minimum size 1,6 x 1m) is compulsory while parking, repairing, refuelling the motorcycle in the paddock or on track. All participants have to respect the night-time curfew from 22:00. It is forbidden to destroy the flora and fauna in the whole event area. Any violation of the environmental rules will be penalised by a fine of 33 €.
