



Supplementary regulations

International Trial Championship of Slovak Republic, Poland and MACEC CUP; SMF Cup for Youth and Hobby class

1. The competition is organised according to the National Motorsport regulations of the SMF for Trial, valid for 2013 and this Supplementary Regulations. The race can attend holders of FIM and UEM licence, holders of SMF-licence type A or B for trial, holders of licence for another disciplines within SMF, or one-shot licence (valid only for certain race) for competitors without licences mentioned above. Foreign riders associated in other National Federations can start with own valid licence. The event is announced for groups A, B, C, Youth (up to 12 years), Hobby and Classic-Trial.
2. Valid for race included into MACEC: Competitors united in National Federations of BMX, SMF, FMU and PZM and starting in groups A or B, will be ranked in the MACEC CUP.
3. **Place of the event:** Kysak, area of VŠBM (former motocross area)
GPS coordinates: N: 48°51'0.68''
E: 21°12'28.73''
4. **Date of the event: 29.6.-30.6.2013**
The track leads outside of the civil traffic. The length of one lap is 5 km, where each lap has 8 sections, 7 sections for class Hobby, Youth and Classic-trial, 4 laps for all groups. The total riding time is 300 minutes.
5. The event has mass SMF insurance but each rider will confirm by signature on the Technical card, that he is insured according to the National regulations of SMF. The organiser doesn't undertake responsibility for any possible damage and losses occurring in relation to competitors and their equipment as well as directly or indirectly to third-parties and their property.
6. According to the valid general rules of SMF, riders without driving license are not allowed to ride bikes outside the race course.
7. Administrative and technical control will be done according to the regulation NO52,1 of the National regulations of SMF.

12. Environment: Washing up motorbikes is forbidden, except appointed place, where it is not allowed to use any chemicals for cleaning. It is allowed to put used oil and another waste only into appointed containers. For every service working with the motorbike it is necessary to use the pad made from absorbing material with dimension 2x1 m. All participants have to respect night-still during the period of time decided by the organiser. All participants have to take care about the plants and fauna in competition place. After breaking any environmental rules mentioned above, the organiser has the right to penalise the violator by 33,-€ penalty.
