



SUPPLEMENTARY REGULATIONS



International Trial Championship of Slovak Republic and MACEC Trial Cup, SMF Trial CUP, Junior and Youth Cup, Jaroslav Fojtík's Cup

ORGANIZER: Trial klub Kamikadze Zbora 124, 020 51 Dohňany, Slovakia, IČO: 42375908

- 1. The competition** is organised according to the SMF National sporting code for Trial, valid for 2018 and these Supplementary Regulations. The race can be attended by holders of FIM, FIME, SMF licences and one-event licence for the appropriate discipline. Foreign riders can participate with valid licence and a start permission of their National federation. The event is announced for groups A, B, C and Student under 8 years and Student over 8 years as International Slovak Championship. Categories Free, Hobby, Women and Classic as SMF Cup. Category classic is for motorcycles made before year 1992. Junior Cup, Youth Cup and Jaroslav Fojtík's Cup result announcement will be done for both days together. Junior class is for riders up to 21 years of age, Youth up to 14 years of age, not depending of motorcycles capacity.
- 2. Colour coded categories:** **A** - yellow, **B** - green, **C** - red, **Student, Women** – blue, **Hobby & Classic** – blue + blue with letter C, **Free** – white
- 3. Venue:** **Zbora & Mestecká skala**, (GPS: 49.181933, 18.279170)
- 4. Date of the event:** **21. – 22.07.2018**
- 5. The track** leads outside of the civil traffic. The length of one lap is 6 -7 km, where each lap has 10 sections, and 3 rounds. Length of lap for categories Student and Women is approximately 0,5km, has 8 sections and 3 rounds. Riding time is 360 minutes, category student 180 minutes. Terrain: clay, roots, rocks, steep exits, jumps and artificial barriers.
- 6. The event** has the third-party liability insurance cover. Each rider will confirm with his signature on the Technical card, that he has an accident insurance cover, foreign riders also medical treatment, transfer to a hospital and repatriation insurance cover. The organiser doesn't undertake responsibility for any possible damage and losses occurring in relation to competitors and their equipment as well as directly or indirectly to third-parties and their property.
- 7.** According to the valid SMF general rules, riders without driving license are not allowed to ride bikes outside the race course.
- 8. Administrative and technical control** will be done according to the regulation NO52,1 of the SMF National sporting code.
- 9. Entry Fee:**
20 € / day;
Hobby – 15 € / day;
Women – 10 € / day;
Student with valid SMF license – no entry fee
- 10. Licences:** Every rider has to be a holder of a valid licence – annual or one-event.



11. Financial reward: first 3 riders in category A and B will get financial reward according to their position for both days. In case of a tie, better result on Sunday will be decisive.

16. Environmental regulations: Washing of motorcycles is forbidden, except for areas designated for this purpose. The use of any chemical substances is not allowed. It is forbidden to spill used oil and another waste outside of marked containers. The use of environmental mat (made of absorbing material, minimum size 1,6 x 1m) is compulsory while parking, repairing, refuelling the motorcycle in the paddock or on track. All participants have to respect the night-time quiet time from 22:00. It is forbidden to destroy the flora and fauna in the whole event area. Any violation of the environmental rules can be penalised individually by a fine of 33 €.



17. Protests: Protests may be lodged only according to the SMF National sporting code for trial – a written protest together with a deposit of 35 € must be given to the clerk of the course within 30 minutes after the result announcement. The deposit will be returned if the protest is justified. Protests in sections are inadmissible.
