## MINUTES OF THE GENERAL ASSEMBLY MEETINGS

### 1993 Congress - Dublin (Ireland)

(24 - 30 October)

The meetings of the General Assembly were held at the Burlington Hotel, in Dublin, Ireland, on 25, 26, 29 and 30 October 1993, under the presidency of Mr. Jos Vaessen, FIM President.

#### Official opening of the 1993 Congress

The official opening ceremony of this 114th Congress took place on Monday morning, 25 October, in the National Concert Hall under the auspices of the Motorcycle Union of Ireland and in the presence of the National Delegations and the FIM officials.

#### Q. 1      Opening address of the FIM President (Annual Report of the FIM)

**The President** requested the General Assembly to observe a minute of silence in memory of FIM Delegates and motorcycle champions who had passed away since the 1992 Congress, namely, Messrs. Oldrich Haken, Gert Raschig, Helmut Fath, Camillo Mattioli Foggia, Stanley Woods, Roman Pijanowski, Gaptrakhman Kadyrov, Hans-Günter Meyer, Carlo Alberto de Ambroggi, Nobuyuki Wakai, Nicolai Nishenko and Alberto Pettinelli.

He then presented a detailed report of the year 1993, which was distributed to all the Delegates (see attached).

**Mr. Mazeran (FFM)** requested that, following the remark of the Belgian Federation at the 1992 General Assembly, the President's address be submitted to the approval of the General Assembly, by secret vote.

Following a secret vote, the Annual Report of the FIM was approved by the General Assembly.

**Q. 6 FIM Membership**

**6.1 Situation of the FISA-CI (Ivory Coast)**

The General Assembly agreed to withdraw this Federation's membership, as it had not paid its admission and subscription fees since the 1991 Congress.

**6.3 Slovak Motorcycling Federation (SMF)**

The President, on behalf of the Management Council, proposed to the General Assembly, following the partition of Czechoslovakia into two separate countries, to accept the request of the CSMF to be split into two separate Federations, as mentioned above. Complete affiliation files had been submitted, as well as the compromise agreement of the two bodies.

The General Assembly accepted this solution by acclamation.

**6.4 Avto Moto Sojuz na Makedonija (AMSM)**

The Secretary General indicated that this Federation was already active and that the affiliation file was complete and in accordance with the Statutes.

The General Assembly accepted this affiliation by acclamation.

**AG DECISION 15/1993**

**6.5 Federacion Dominicana de Motociclismo (FDM)**

The Dominican Delegate indicated that his Federation had been working in view of this affiliation for more than 20 years. The FDM was a founding Member of the ULM and organised National Championships for Road Racing, Motocross and Enduro.

The General Assembly accepted this affiliation by acclamation.
