

## **INSTRUCTIONS FOR 2025 RIDER'S LICENCE APPLICATIONS AND LICENCE FEES**

The filled-in application form with the medical confirmation needs to be send together with the appropriate licence fee to the SMF secretariat. The application form can be found on the SMF web site: http://www.smf.sk/smf-formulare/.

When paying by a bank transfer, please indicate rider's name in the message for the recipient.

The application form of riders under the age of 18 must be signed by both parents (or legal guardians). The signatures must be verified at notary.

Riders over the age of 50 must attach with the medical confirmation also the **ECG result**.

New riders of the youth motocross (classes 50cc, 65cc, 85cc) must also attach a **photocopy of their birth certificate**.

If a rider with permanent residence outside the territory of Slovakia applies for a licence for the World Championship/Cup or European Championship/Cup for the first time, he/she is according to the FIM regulations obliged to request the FMN of his home country to issue a rider's release. Without receiving this release, the FIM / FIM Europe licence in question will not be issued and the application will be rejected. From the 2024 season onwards, it is not necessary to submit a release with the application for an international licence - see FIM Sporting Regulations Art.70.2.1

For the 2025 season, all licenses will only be sent by e-mail to applicant's e-mail address in PDF format. After the applicant sends a complete application form and makes relevant payment of the licence fee, the licence will be sent to his/her email address. SMF International licences are issued in two different ways, the SMF licence in pdf format + the FIM online licence for events open to foreign participation. The procedure for issuing an online FIM license: after submitting an application, the SMF will order this license in the FIM licence system, the FIM will send the required documents to this email address of the applicant. The documents must be electronically signed (link in the email received from FIM). Once the documents have been electronically signed, the FIM will send the relevant licence electronically (by e-mail) to the rider. The rider saves the licence on

his/her mobile phone or prints it in pdf format. For categories and classes for which the FIM online system does not issue international licences, the SMF will only issue an online SMF "A - International" licence, which includes the start permission. These are the RR youth, vintage and MX50 licences.

## **SMF LICENCE TYPES:**

International licence type **A** – holders of this type of licence can participate at national SMF events and also at international events abroad (**not** World Championship/Cups or European Championship/Cups). The use of this type of licence abroad is only allowed with a start permission. The start permission can only be issued to riders with appropriate insurance cover valid for medical treatment, transfer to a hospital and repatriation and for the case of permanent disability and death after an accident.

National licence type **B** - holders of this type of licence can participate at national SMF events.

For World Championship or Cups or European Championship or Cups the appropriate *FIM or FIM Europe licences* are needed.
